All India Adult Education Conference held at University of North Bengal, Siliguri



The 63rd All India Adult Education Conference jointly organized by Indian Adult Education Association, New Delhi and the Department of Lifelong Learning and Extension, University of North Bengal, Siliguri which was attended by 230 delegates from 18 states and UTs - Andhra Pradesh, Assam, Bihar, Gujarat, Haryana, Jammu & Kashmir, Kerala, Madhya Pradesh, Maharashtra, Meghalaya, Odisha, Rajasthan, Sikkim, Tamil Nadu, Tripura, Uttar Pradesh, West Bengal and NCT Delhi representing NGOs, CBOs, Universities, Colleges, State Resource Centres, Jan Shikshan Sansthans, Adult and Lifelong Education practitioners, field functionaries and freelancers. The three day programme was divided into 13 plenary sessions and one general session. In plenary apart from Keynote Address, 47 papers based on empirical as well as experience based were presented. UNESCO released Global Education Monitoring Report 2019

The UNESCO released Global Monitoring Report 2019. It is titled "Migration, Displacement Education: Building Bridges, not Walls".

Migration and displacement interact

with education through intricate, two-way relationships that affect those who move, those who stay and those who do or may host migrants and refugees. When in the life

cycle people ponder or undertake migration is a key determinant of education investment, interruption, experience and outcome. Children migrating from areas with lower levels of education development may access opportunities otherwise unavailable. At the same time, migrant students' attainment and achievement often lag behind those of their peers in destination communities.


Migration and displacement require education systems to accommodate the needs of those who move and those left behind. Countries need to recognize migrants' and refugees' right to education in law and fulfill this right in practice. They need to tailor education for those cramming into slums, living nomadically or awaiting refugee status. Education systems need to be inclusive and fulfill the commitment to equity. Teachers need to be prepared to deal with diversity and the traumas associated with migration and, especially, displacement. Recognition of qualifications and prior learning needs to be modernized to make the most of migrants' and refugees' skills, which contribute greatly to long-term prosperity.

Following are some of the highlights:

- Migration and displacement require education systems to accommodate the needs of those who move and those left behind.
- An estimated 763 million people live outside the region where they

were born.

- In 2012, around 17.2 million children aged 5 to 17 were in paid or unpaid domestic work in an employer's home.
- In 2000, global emigration rates



The degree of refugee inclusion varies across displacement contexts,

affected by geography, history, resource availability and system capacity.

- A lack of required documents, language barriers, missed education and hidden costs can hinder full inclusion.
- There are few if any specialized schools in displacement locations, • and they typically charge fees.
- Only 1% of refugees are in tertiary education.
- Internally displaced teachers often face risks and administrative hurdles that make collecting salaries virtually impossible.
- Education can mediate negative media portrayals by providing political knowledge and critical thinking skills to decipher fact from fiction.
- By promoting respect for diversity, and economic advancement, education can be a

- Half of all international students move to five English-speaking countries, while three countries in Asia accounted for 25% of all outbound mobility.
- As of 2018, four new indicators will be reported on for the first time, bringing the total number of SDG 4 indicators being measured to 33 out of 43.
- Migrant households are mobile and less likely to be present for household survey enumerator visits or to interview due to language barriers or legal concerns.
- To achieve universal secondary school completion by 2030, the current cohort needs to enter primary school on time.
- Labour force surveys are a preferable source administrative data to measure adult education given the diversity and number of providers.
- Three in ten adults do not know how to attach files to emails in high income countries.
- Rural students have only around half the chance of their urban peers of completing upper secondary education in low and middle income countries.
- Between 2013 and 2017, there were over 12,700 attacks on education.
- The EU's higher education strategy includes a target for at least 20% of graduates to experience part of their study abroad.
- Annual global spending on education is approximately US\$4.7 trillion, of which 65% is spent in high income countries.
- The share of basic education aid to low income countries fell from 36% in 2002 to 22% in 2016.
- The causality of the relationship between international aid and migration flows is difficult to establish.

University, Tirupati, Andhra Pradesh. The Co-Chair was Dr. Asha Verma, Assistant Professor, Gujarat National Law University, Gandhinagar.

This session was devoted to Keynote Address which was delivered by Dr. Arun Kanti Jana, Professor, Department of Political Science, University of North Bengal on the topic "The State and Rural Development: The Issue of Poverty Alleviation and Literacy in Independent India ". In his address he explained in detail about various government initiatives to mitigate poverty alleviation in rural India like land reforms, green revolution, Jawahar Gram Samridhi Yojana, Swarn Jayanti Gram Swarozgar Yojana, Mahatma Gandhi National Rural Employment Guarantee Scheme, etc. He also touched upon low literacy in rural areas though schools are opened almost in all the villages and the primary education is in mission mode. He concluded his address by stating that the experience with rural development through poverty alleviation measures and spread of literacy and adult education had been sluggish in India because of the marginal importance given by successive governments since independence. The concern of the state in recent years, more particularly since 1991, had mainly been economic growth and this concern will not be able to take the country to attain the objective of sustainable development which is one of the objectives of United Nations development programme.

Subsequently, the remaining 12 plenary sessions were held in Humanities Building both in Room No. 109 and Smart Classroom of Department of Lifelong Learning and Plenary Session – 3 Extension.







Dr. Sanchari Roy Mukharjee in her valedictory address stressed the need and importance of adult

education as children in large number dropout of the school for various reasons and remain as illiterates. A vast country like India with large number of illiterates cannot progress well and make social welfare programmes a success. Participation of all



sections of society is important for achieving inclusive growth. Unfortunately, while all other sectors of education are given priority in fund allocation, adult education sector gets meager amount due to which there is always a shortfall in the end result.

Illiteracy in rural areas is much more than the urban areas. Rural areas are equally important as they control and manage the rural economy which is important for the development of the country. The governments,

both central and states, formulate a number of schemes focusing on rural areas but the success rate is not encouraging. This may be due to people either not aware of the schemes or not able to get the schemes because of lack of education. This can be rectified by bringing them to the education fold through adult education classes wherein they can learn literacy and get awareness inputs on various aspects which are of immediate importance to their day-to-day life.

She also narrated a life experience about her grandmother who was married at the young age of 12 and hence, she could not attend school and remained as an illiterate though grandfather was the Head Master of a school. However, she was taught the basic literacy at the age of 22 by grandfather after three children were born which enabled the grandmother to read Mahabharata which was closely observed and admired by Dr. Sanchari as a child. This made her to study well only to read Mahabharata like her grandmother. She said today she has reached a much greater heights and holds the position of Dean in the prestigious North Bengal University.

Declaration and Recommendation

The Sixty Third All India Adult Education Conference was jointly organized by Indian Adult Education Association, New Delhi and the Department of Lifelong Learning and Extension, University of North Bengal at Siliguri from November 27-29, 2018in which 230 delegates participated from Andhra Pradesh, Assam, Bihar, Gujarat, Haryana, Jammu & Kashmir, Kerala, Madhya Pradesh, Maharashtra, Meghalaya, Odisha, Rajasthan, Sikkim, Tamil Nadu, Tripura, Uttar Pradesh, West Bengal and NCT Delhi representing NGOs, CBOs, Universities, Colleges, State Resource Centres, Jan Shikshan Sansthans, Adult and Lifelong Education practitioners, field functionaries and freelancers. The three days programme was divided into 14 plenary sessions and one general session. In plenary apart from keynote address, 47 papers based on empirical as well as experience based were presented.
